## **CONDITIONS OF PARTICIPATION GAMSLEITEN CRITERION 2024**

### **1. GENERAL PROVISIONS**

- a. By purchasing or receiving a ticket, the purchaser agrees to the conditions of participation.
- b. Participants acknowledge the organiser's exclusion of liability for damages.
- c. The instructions of the security personnel must be followed at all times.
- d. The organiser reserves the right to exclude persons who violate these conditions of participation, endanger themselves and other participants or act unlawfully in any other way and shall be immediately excluded from participation without any claim for compensation on the participant's part.
- e. The general FIS piste rules and the conditions of carriage of the Gamsleitenbahn apply.
- f. For safety and logistical reasons, the organiser reserves the right to limit the number of participants at any time and to change the location or mode of participation in bad weather.
- g. Participation is possible from the age of 15, whereby up to the age of 18, the consent of a parent or legal guardian must be submitted in writing.
- h. The play area is located in high alpine terrain. The associated risk cannot be excluded entirely; the participant bears the remaining risk.

### **2. PARTICIPATION**

- a. The purchased or received ticket must be opened, assigned to a person and handed in directly at the registration office in the Obertauern Tourist Office between **12:00 and 24:00 on Friday, 12 April 2024**, as part of the start number draw. This gives you the right to participate in the Gamsleiten Kriterium. The drawn starting number is also the starting order for the treasure hunt.
- b. The participant expressly accepts to waive claims to any special prizes in connection with the ascent. The ascent via the Gamsleiten 1 is recommended for every participant in the treasure hunt. The ascent is included in the ticket price for the treasure hunt (single ride on the Gamsleiten 1). A valid start number and ski or snowboard equipment are mandatory for every participant for the Gamsleiten 1 ascent.  
Supplement to b.) Since 2022, participation in the treasure hunt has also been permitted for people who, for individual reasons, are not willing or not able - in terms of skiing ability - to take the Gamsleiten 1 cable car uphill or downhill from the Gamsleiten. All participants who wish to tackle the treasure hunt without skis/snowboards will be queued behind the participants making the descent from Gamsleiten 1. The start for the "non-skiers/snowboarders" is, therefore, immediately (by start number) after the last of the "skiing/snowboarding" participants have started.

c. Backpacks and bags, other transport containers and dangerous objects must be handed in to the security staff before the start. If the participant refuses to leave certain items behind, the organiser reserves the right to exclude the participant from the event.

d. Participants will be ranked according to their start numbers. Those who do not arrive on time at the start will be ranked later. **If the race number jersey is lost, € 20.00 per jersey will be charged.**

e. During the search operation in the sector(s), skis, snowboards and poles must be deposited in areas marked at the edge of the piste. The piste areas open for downhill skiing are outside the search sector/sectors.

f. Only those items provided by the organiser are permitted for searching the boxes. Objects brought along (e.g. skis, ski poles, probes, snowboards) and animals (e.g. search dogs) may not be used and will lead to disqualification in the event of non-compliance. Knee pads are permitted.

g. If a treasure chest is found, it must be brought to the responsible notary with the start number in the finish area. To establish the finder's identity, a valid photo ID must be presented to the notary to avoid confusion at the subsequent prize-giving. Only one treasure chest may be redeemed per participant.

h. In case of doubt, referees present in the sector(s) provided by the organiser will decide who the finder is. If the respective referee cannot identify the finder, the final decision will be made by drawing lots. Should a dispute arise between two or more participants, the organiser reserves the right to disqualify these participants.

i. The sealed boxes may not be opened under any circumstances. This is the responsibility of the responsible notary. In the case of previously opened or damaged boxes, the organiser reserves the right to exclude the participant concerned from the chance to win. These prizes may be raffled off among all starters.

j. If one or more treasure chests are not found within the specified time, they will be raffled off among all present participants at the official opening.

k. The prize cannot be redeemed in cash and is not transferable.

l. The Obertauern Tourist Board and BMW Austria GmbH assure that the data collected will be treated confidentially in accordance with data protection regulations. The participant expressly agrees that the organiser may use the data disclosed/transmitted to them for this competition and future information. My data will not be processed for any other purpose and will not be passed on to third parties. bb. seek to improve their chances of winning by manipulation;

cc. violate the conditions of participation in any other way.
